## Basic Aim

---

- The Barcelona GSE Research Network *Recognition of Research* Program aims to recognize, stimulate and publicize international economic journal publications of high impact of all researchers working in any university or research center in Catalonia.

*Notice that at the end of 2007 CREA/XREA became the Barcelona GSE Research Network.*

# Basic Rules (I)

---

- Any researcher currently under contract with a university or research center in Catalonia is eligible.
- Only articles in which the corresponding affiliation with the University or Research Center in Catalonia appears are eligible.
- To participate in the program, the researcher must send the Barcelona GSE Research Network a list of all articles published in the approved journals (see “List of Journals”) in the previous three years (2005-2007 for this call), and not already recognized in previous years.

# Basic Rules (II)

---

- Articles accepted to the program will be publicized as part of the Barcelona GSE Research Network's output and also as part of the contract with the Government of Catalonia. The authors may be invited to present them in special events organized by the GSE Research Network or to contribute them to other events of the GSE community.
- For current recipients of support, only those articles that explicitly show the support of the GSE Research Network are eligible. The following statement should be included in the acknowledgments: *'The author acknowledges the support of the Barcelona GSE Research Network and of the Government of Catalonia'*.  
(NOTE: Since this involves a change from previous editions, in the present edition any reference to CREA or XREA will also be accepted).
- For Barcelona GSE Affiliated Professors, an affiliation as “[name of institution] and Barcelona GSE” is also highly recommended.

# Basic Rules (III)

---

- All those participating in the program who are not Barcelona GSE Affiliated Professors, will automatically be invited to become *research affiliates* of the Barcelona GSE Research Network.
- Participation in the program also means a commitment to participate in other activities of the GSE Research Network, such as *La Trobada* or the *Barcelona Economics Lectures*.

# Weighting of Journals

---

- International economic journals of high impact:  $\omega_1 = 1$
- Economic field journals of high international impact:  $\omega_2 = 2/3$
- Economic journals of broad international impact:  $\omega_3 = 1/3$

# Weighting of Journals

---

- $n$  coauthors ( $n \geq 2$ ) and  $m$  affiliations (not counting CREA/GSE Research Network, CREI, CODE, CEPR, NBER, Barcelona GSE, etc.)  $\omega_i(1.8/n)(1/m)$
